

RESOLUTION 2005-7

A RESOLUTION DIRECTING THE SALE OF SURPLUS PERSONAL PROPERTY OF THE CITY OF CENTRAL CITY, NEBRASKA.

WHEREAS, the City of Central City does have in its possession certain vehicles deemed to be beyond their useful life to the City, with a fair market value of less than \$5,000, and wishes to dispose of these vehicles; and

WHEREAS, State Statute 17-503.02 allows for the sale of surplus personal property by posting the sale in three prominent places within the City for a period of not less than seven days prior to the sale; and

WHEREAS, the sale will be conducted as a “sealed bid auction” with the following instructions:

1) Bids must be submitted in a sealed envelope, on a City Bid Sheet. The envelope must be marked on the front, with the year, make and model of the vehicle being bid on.

2) Only one bid shall be submitted per envelope.

3) Bids will be accepted through April 28, 2005 at 5:00 p.m.

4) Bids will be opened on May 2, 2005 at 9:00 a.m., and the high bidder will be notified of their successful bid as soon as possible.

5) The high bidder, regardless of city staff's ability to contact such bidder, will have until May 6, 2005 to make full payment. The failure to make such payment will result in either a) the City accepting the next highest bid, or b) the City rejecting all bids and canceling the sale.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and City Council of the City of Central City that the following City vehicles be sold according to the terms listed above, with minimum bids in parentheses:

1989 Ford Econoline Wagon (\$250)

1985 Dodge ½ Ton Pickup (\$250)

1997 Ford Crown Victoria (\$400)

1977 Dodge W200 Pickup (\$200)
